


# Acceptance Form for International Students



# Congratulations on receiving an offer to study at ECU. In order to accept this offer, please read the instructions in this brochure and follow them carefully.

#### 1. Letter of Offer

The Letter of Offer you have already received outlines the course you have been offered, the usual course duration, the year and semester you will be commencing your studies, the campus where the course is offered, the Orientation date, and any conditions of entry.

This letter contains important links to further information about your course, studying at ECU, Overseas Health Cover (OSHC), and living in Western Australia. It also gives you the link to the Department of Immigration website, where you can find out how to obtain your student visa,

It also outlines the fees you have to pay in order to accept your offer. It can take time to obtain a student visa, so we advise you to accept the offer early to allow yourself sufficient time to obtain your visa.

## 2. Accepting your offer

If you would like to accept this offer to study at ECU, you must follow the following:

- A. Complete this Acceptance Form.
- B. Read the Conditions, Authorisations and Declarations to confirm your acceptance.
- C. Please pay the tuition fees and the Overseas Student Health cover as outlined in your letter.

# 3. How to pay



Payment can be made in your preferred currency from overseas via bank transfer or credit card. Log in via the secure ECU Western Union website www.pay24-7.com/ecu.

Upon receipt of your payment, we will issue your Confirmation of Enrolment (COE). Your Acceptance Letter will also will be issued to you if you have received an Unconditional Offer.

# 4. If your offer is 'conditional'

You must submit your supporting certified documents (Academic or English results) to meet the Conditions identified in your offer letter.

Please note that if you have received a "Conditional Offer" you must satisfy these "Conditions" before you can be admitted to ECU and before you may receive a Conditional Confirmation of Enrolment (CoE).

#### 5. Confirmation of Enrolment

Your Confirmation of Enrolment (COE) is the document you require to obtain your student visa. It contains information about the course you will be enrolled in, the course duration and the indicative course fee payable. It is your responsibility to ensure that the information on the COE is correct before you submit it to obtain your visa.

- 8. I understand that I may be required to provide the original documents of the scanned copies that I submitted with my application. If I am unable to provide original documents, or these documents are found to be fraudulent in any way, my enrolment may be cancelled.
